## Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Teachers and staff set ongoing academic targets and daily student objectives based on the Common Core Standards for their grade level. Teachers are trained in best practices for instruction and use assessment data to determine who is meeting the grade level goals and who

needs additional support and intervention. When students are struggling with behavior, academics or social-emotional concerns, an SST (Student Success Team) meeting is held with parents to discuss interventions and determine how the school can help to support the student and the family. A school climate survey is sent out in May each year to get feedback from parents, staff and teachers regarding school climate, learning environment, and student and family needs.

A description of how students will be identified and the needs of students will be assessed.

Teachers use regular formative and benchmark assessments to monitor student progress toward proficiency in all academic areas. In addition to these local indicators, state indicators including the CAASPP, CAST, CSA and ELPAC are used to analyze student progress and identify gaps and needs. The school counselor talks with parents when students share needs and exhibit stress or anxiety at school. Parents are encouraged to share with teachers via Parent Square when they have student and family needs that are not being addressed.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Regular, ongoing school communication takes place daily via Parent Square, both with schoolwide messages that include opportunities for all students, and group messages for specific targeted groups of students, and individuals as needed. Transportation is provided for students to attend extended year programs such as Summer School.

A description of the LEA's plan to provide supplemental instruction and support.

The Supplemental Instruction and support will include the following components:

- 1) Extended day, extended year programs: 3 week Summer School program for grades K-8th--Extended school year program; 3 hrs per week after school learning support program which includes reading, math, drama, music and dance;
- 2) The implementation, expansion or enhancement of learning supports: Classroom furniture to support in person learning and meet COVID protocols; Bilingual Instructional Assistants to provide targeted interventions to meet the needs of students who are EL, Low Income, Homeless, Below grade level and those with disabilities;
- 3) Integrated student supports to address other barriers to learning: Part time .3 FTE counselor to support students with social emotion and mental health needs  
School nurse 1 day a week to provide additional support for EL, Low Income, Homeless and Students with Disabilities  
Parent volunteer Coordinator to increase engagement for parents of EL, Low Income, Homeless and Students with Disabilities;
- 4) Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports: Software to support student learning in Spanish and English:  
Technology and equipment to support all students with increased access to standards based curriculum (View Sonic Boards and Doc Cameras for increased classroom access for in-person and distance learning formats
- 5) Additional Academic Services for students: Bilingual Instructional Assistants support at risk students with targeted interventions in Spanish and English Language Arts and Math
- 6) Training for school staff on strategies to engage students and families in addressing students' social-emotional health and academic needs: All new staff trained in Project GLAD (Guided Language Acquisition Design), Benchmarks Adelante, Eureka Math and CPM Math; Latino Family Literacy Project training to support families with academic and literacy support to increase parent engagement: All staff receives ongoing training in HEARTSMART SEL Curriculum.

This includes additional bilingual instructional support, curriculum, transportation, after school program, food services, counselors, professional development and extended year and extended day offerings.

## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
